FINAL JUDGMENT

The above action came on for trial before a jury and the jury having returned its verdict, and the Court having considered the parties' post-trial briefs in support of judgment, and the findings, conclusions and recommendations of the United States Magistrate Judge as to attorneys' fees, the Court enters the following judgment:

It is ORDERED, ADJUDGED AND DECREED that Southwest Hide Company have judgment over and against Fred Goldston for damages in the sum of Ten Million Six Hundred Eighty Thousand and no/100 Dollars (\$10,680,000.00).

It is further ORDERED, ADJUDGED AND DECREED that Southwest Hide Company have judgment over and against Fred Goldston for its reasonable attorneys' fees and expenses in the amount of One Million Sixty-Three Thousand Four Hundred Forty-Nine and 31/100 Dollars (\$1,063,449.31).

It is further ORDERED, ADJUDGED AND DECREED that this judgment be credited with sums received by Southwest Hide Company from settlements with other persons and entities prior to April 14, 1992, in the sum of Nine Million Four Hundred Eight Thousand Eighty-Five and 69/100 Dollars (\$9,408,085.69). Southwest Hide Company is ORDERED to report to the Court annually, beginning one

year from the date of this Judgment, the amount of net settlement proceeds received after April 14, 1992, from the bankruptcy estates of Amarillo By-Products, Inc., Millard McAfee, Richard Jerome, David Kennedy, Fred Goldston, and Panhandle Processing Company, Inc. The net proceeds received by Southwest Hide Company from these bankruptcy estates shall be credited to this Judgment as received.


It is further ORDERED, ADJUDGED AND DECREED that Southwest Hide Company recover post-judgment interest on the amount hereby awarded at the rate of 3.76 percent per annum from this date until paid.

Southwest Hide Company is further awarded its taxable costs of court, which are a part of the judgment hereby entered. Southwest Hide Company is awarded issuance of all writs and process for the collection of this Judgment, subject to any applicable stays or orders of a United States Bankruptcy Court.

All other relief requested and not awarded herein is denied.

The Clerk shall furnish a copy hereof to all attorneys.
